

A MESSAGE FROM THE CHAIR

As you flip though our annual report you will learn a bit more about what we were up to in 2018-19. As per usual, Sombrilla punched above its weight as a small, completely volunteer-run international development organization.

Our most notable activities in 2018-19 include:

- continued support to the Tierra Colorada school in Guatemala;
- coordinating a final service trip to improve access to urogynecological services in the highlands of Peru;
- another year of supporting the Jose Garcia Scholarship Fund for post-secondary students and community activists in El Salvador:
- completing our food security project in Peru constructing green houses to improve the food security of families; and
- starting a new major project creating economic opportunities for youth in Honduras in order to encourage them to remain in their communities instead of seeking refuge abroad.



We also wish to thank an anonymous donor who came to Sombrilla with a desire to work with our partner in Honduras to improve food and nutritional security with Mayan Chorti families with this project beginning in 2018-19.

2018-19 was also a year of renewal for our board of directors. This year we welcomed five new board members who are all sharing their talents to support Sombrilla's mandate and partnerships in Latin America. Unfortunately, Abyad Rahman and Nancy Tran both had to step away from our board in 2018-19 but we are grateful for the time and energy they dedicated to our organization.

To all of those that contributed to Sombrilla – whether as a donor, volunteer or attending one of our events – thank you for being a part of the journey in 2018-19. I am looking forward to working with you in 2020, which will no doubt be another promising year for Sombrilla.

NOTABLE EVENTS

THE INTERNATIONAL DINNER 2019

On April 6 2019, Sombrilla hosted its annual International Dinner at Edmonton's Strathcona Performing Arts Center. It featured Sebastian Barrera's live music, a live auction, silent auction, and catered dinner. We watched a presentation by "Los Tres Amigos", Charlie Pearson, Michael Hoyt, and Kevin Swallow. We heard about the board's trip to El Salvador where they met with community leaders and collaborated to develop new projects. The International Dinner raised \$18000 in revenue, which is allocated toward development of these new projects.

EL SALVADOR TRIP

Michael Hoyt, Charlie Pearson, Katrin Hoffman, and Kevin Swallow visited ongoing projects in El Salvador. They met with community leaders and local participants of the Scholarship and Physiotherapy Projects. Through discussions with community members, Sombrilla helped the community to develop a plan for a second phase of the project, which has since been completed. Residents also expressed interest in building a community center, which has now developed into the Community Learning Center project. This project supports local programming at the center in Yurac Yacu, such as early childhood education and a library.



PROJECTS THIS YEAR

COMPLETED:

Physiotherapy - Phase 1, El Salvador (Feb 2019)

Addressing long-term health issues of women in rural areas through targeted physiotherapy treatment by local professional and preventing future issues with education and training.

Partnered with CEBES-Perquin with a budget of \$3,500.

Physiotherapy Project - Phase 2, El Salvador (May 2019 - Aug 2019)

Continuation of Part 1 of the Physiotherapy Project. Part 2 involved a local professional bringing services to women in more remote regions than in Part 1, with a budget of \$5,000

Guatemala - Tierra Colorada School Project

Supplementing salaries for 12 teachers at the Tierra Colorada School, allowing approximately 100 students to attend secondary school (grade 7-9). Recently, the Guatemalan government has started to provide funding and is expected to replace Sombrilla's support in the long term.

ONGOING:

Peru - Yurac Yacu Food Security Project (March 2018 - Feb 2020)

Improving access to healthy and sustainable food by supporting residents to build greenhouses or family gardens, and providing workshops in food production and vegetable cooking.



Yurac Yacu Community Center

Funded by an anonymous donor, supports early childhood education, a library, and community space at the community center. The center also hosts a café, guiding office and knitting cooperative with a goal that eventually these businesses will fund the center's programs.

Scholarship Project, El Salvador

Provides scholarships for young adults from rural communities to complete their post-secondary education. Partnering with CEBES-Perquín with a budget of approximately \$5,000/ year

NEW PROJECTS:

Maya Chorti Food Security, Honduras (Aug 2019 - July 2020)

Improve food security and nutritional intake for approximately 180 community members (30 families) by installing greenhouses and family gardens and providing training to the families.


Partnering with OCDIH with a budget of \$20,000


Youth Employment Project, Honduras (April 2019 - Oct 2020)

Improving opportunities for young people in Honduras to find a job or start a business, decreasing the need for young Honduras to migrate to the US. Partnering with Organismo Cristiano de Desarrollo Integral de Honduras (OCDIH) with a budget of \$60,000
